Test size was 500, respondents were students, teachers, monetary subject matter expert, NRIs, house life partners and workers on everyday pay.

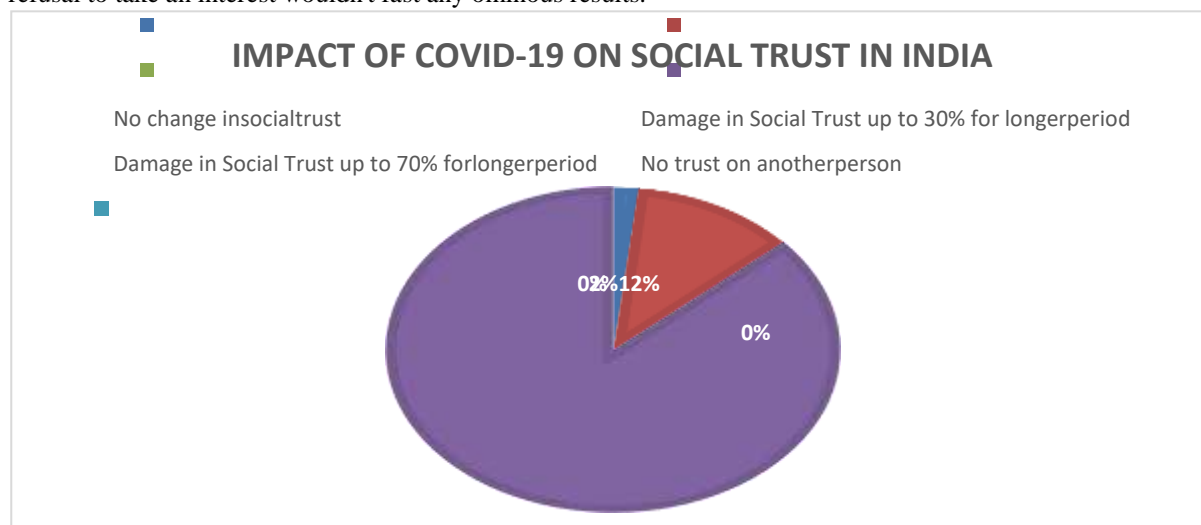

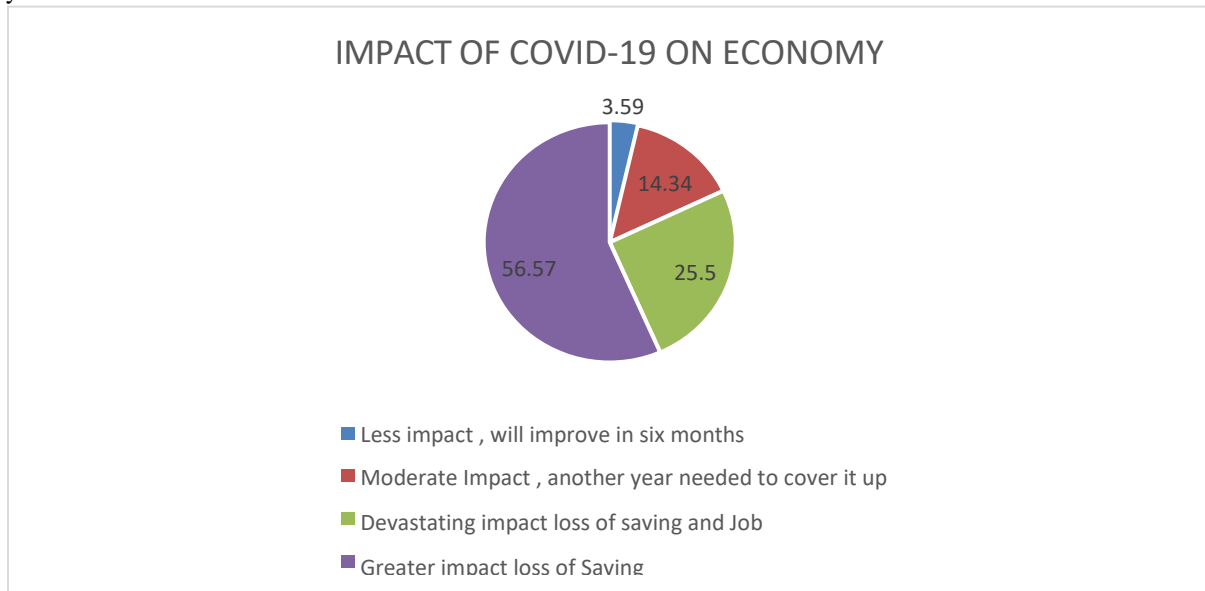
